Under 25 Men Singles Competition 2004

Rules & Regulations

REVISED on 7/10/2004

1. All the games will be played within 1 hour.
2. The commencement and completion of the games are subject to the signal given by the Umpire or Official on site.
3. Upon the release of the completion signal from the Umpire or Official, all bowlers must try to finish any jack delivered end as soon as possible.
4. All bowlers and markers must arrive and report to the official at least 15 minutes before the commencement of their game.
5. If any bowlers or their markers do not show up on the Green at the scheduled time, the bowler will be disqualified from the competition.
6. Any points gained from walk-overed bowlers will be cancelled from the overall competition.
7. The winning bowlers of each game will gain 2 points and for a tie game 1 point to both bowlers.
8. The position of bowlers for all round robin events will depend on the order of the number of points, shot difference, shots for and shots against.
9. If all the above are the same between two bowlers, the position will depend on the result of the game between the two same bowlers.
10. All the other regulations will be according to the current edition of the Laws of the Sport of Bowls by World Bowls Ltd.
